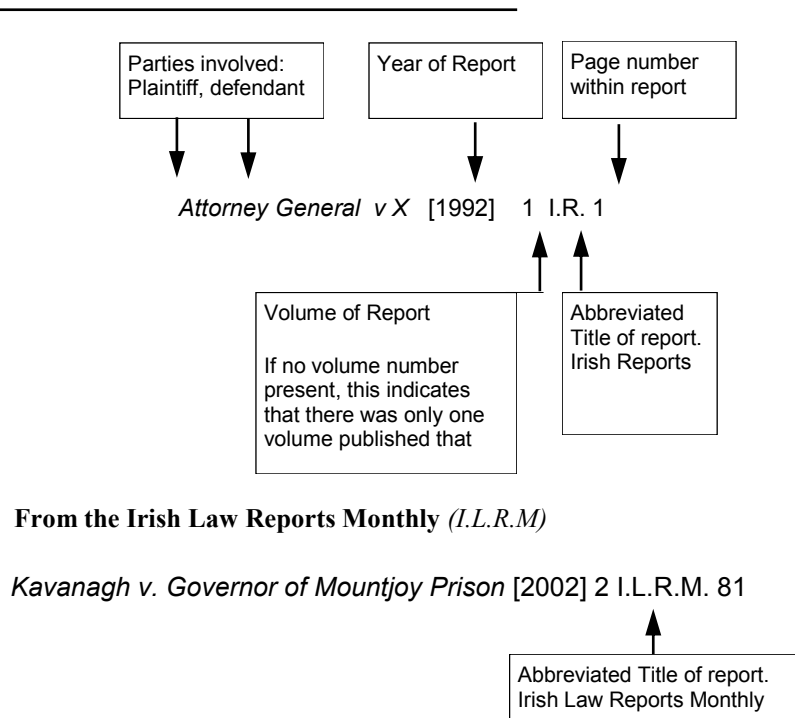
## Understanding Law Citations

A case citation is a reference to where a case is printed in a Report series. Initially many students find citations difficult to understand but it is essentially a matter of familiarity, particularly with the abbreviations. Use the report listing overleaf for a guide to the most common abbreviations you will come across.

For the main Irish and UK reports we have electronic access through databases such as Lexis-Nexis, WestlawIE and WestlawUK so there should be few occasions when you cannot get access to a case.

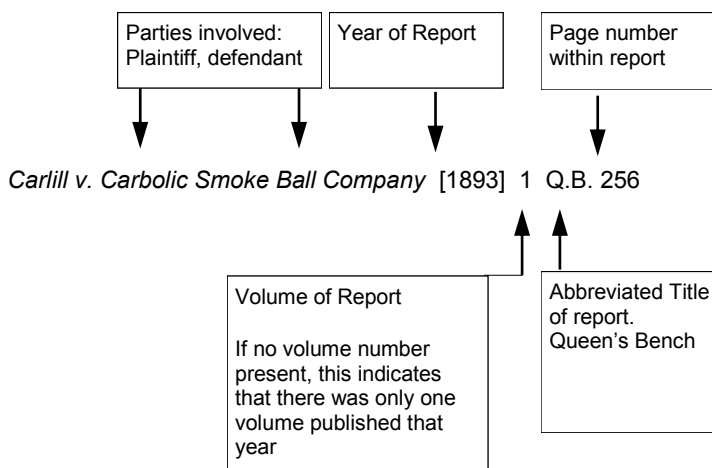
